

INTRODUCTION TO THE AZ LEGISLATURE

THE LEGISLATURE is the government body elected by the people established to vote by majority vote on bills that become bills and make up our state statutes.

There are **49 Chapters of Law** in our current **Arizona Revised Statutes**.

WHAT IS THE LEGISLATURE? WHAT IS THE JOB OF A LEGISLATOR?

LEGISLATORS are the members of the LEGISLATURE that submit bills and vote to establish our laws. The legislators vote to select the leadership of their respective chambers.

There are **two chambers**. House and Senate.

- **House** has **60** legislative members – two members from each district. Led by the Speaker of the House.
- **Senate** has **30** legislative members – one member from each district. Led by the Senate President.
- There are **30 legislative districts** in Arizona

Legislative Schedule

If you want a legislator to run a bill, plan to reach out to them starting in September prior to the next session.


- November – January:
 - Usually, folder opportunities for new bills opens
 - Every new bill must have a folder opened for it with a deadline around February.
- Mid-January: Session opens
- Statutory requirement is for the session to last 100 days minimum
 - A majority vote of the legislature can extend the session
- Budget must be completed and signed by the Governor by June 30th to avoid a shutdown
 - There are options for a “skinny budget” to avoid a shutdown

How a Bill Becomes Law

Bills can be amended after they pass out of committee. If you like the merit of a bill, consider passing it as long as it's not pro-tyranny.

The Governor can veto bills from the Legislature. The Legislature may override the veto with a super-majority vote. They may also run a new bill.



The Speaker of the House or Senate President assign bills to committees. Every non-appropriation bill goes through a standing committee and the Rules Committee. Once a bill passes through one chamber, it starts again in the 2nd chamber.

P.S. We don't put pie on the slides at risk for government to take a piece.



Steps for a Bill to Become a Law

The Legislative Process is Purposely Set Up for Most Bills to Die as a Self-Defense Mechanism Against Bad Laws.

Do Not Count on Any Legislator to Lobby Your Favorite Bill through for You.

1. Speaker/Senate President Assigns Bills to Subcommittees
2. Subcommittee Chairs Assign the Bills to the Agenda to be Heard
3. Subcommittee Members Vote
4. Rules Committee Chair Assigns the Bill to an Agenda to Be Heard
5. If passed, the Speaker/Senate President Assigns the Bill to Agendas to be Heard in a 1st, 2nd, and 3rd Reading where the Committee as a Whole (COW) Votes

Not every bill gets heard. There are deadlines for every step and bills can die along the way if they do not proceed before the deadline.

IMPORTANT DEADLINES - Second Regular Session, 55th Legislature, 2022

- Financial Disclosure Statements - Monday, January 31, 2022
Every "public officer" is required to file a financial disclosure statement with the Secretary of State each year on or before the 31st of January.
(ARS 38-541 - 38-545, 18-444 & 1-303) Electronic forms are provided on the Secretary of State's website.
- Last day for prefiling of bills - noon, Monday, January 10, 2022
House Rule 8D: Bills, resolutions and memorials may be prefiled by any member for introduction in the second regular session during the period from November 15 next preceding the first regular session until the first day of the second regular session.
- Last day for sponsorship of bills before the seven bill limit begins - 5:00 p.m., Thursday, January 13, 2022
House Rule 8C: . . . Every bill, resolution or memorial shall have at least one prime sponsor. A member may not be the prime sponsor of more than seven bills introduced after the fourth day of each regular session. For the purposes of this rule the first name on a bill shall be considered the prime sponsor.
- Last day for House Members to submit bill requests to Legislative Council - Friday, February 4, 2022.
- Last day for introduction of bills - Monday, February 7, 2022
House Rule 8C: Bills, resolutions and memorials may be introduced during the first 29 days of regular session . . . Thereafter, with the exception of death resolutions, introduction may be allowed only with the permission of the Rules Committee.
- Last day for House consideration of House Bills - Friday, February 18, 2022
House Rule 9F: . . . all House Bills shall be considered by committees prior to the Saturday of the week in which the 60th day (March 10) of session falls.
- Last day for House consideration of Senate Bills - Friday, March 25, 2022
House Rule 9F: . . . all Senate Bills shall be considered by committees prior to the Saturday of the week in which the 90th day (April 9) of session falls.
- Last day for consideration of bills in Conference Committees - Friday, April 15, 2022
House Rule 17G: . . . Conference Committees shall consider all bills prior to the Saturday of the week in which the 97th day (April 16) of session falls.
- Adjournment sine die - Saturday, April 23, 2022
House Rule 2A: . . . regular sessions shall be adjourned sine die no later than the Saturday of the week in which the 100th day (April 19) of session falls. (The Speaker and the President may extend the session for a period not to exceed seven additional days. Thereafter, the session can be extended only by a majority vote of the Members.)

HOUSE BILL 2054
Rep. Kaiser LD15 (R)

Be it enacted by the Legislature of the State of Arizona:

Section 1. Section 16-165, Arizona Revised Statutes, is amended to read:

16-165. Causes for cancellation

A. The county recorder shall cancel a registration:

1. At the request of the person registered.
2. When the county recorder knows of the death of the person registered.
3. If the person has been adjudicated an incapacitated person as defined in section 14-5101.

4. When the person registered has been convicted of a felony, and the judgment of conviction has not been reversed or set aside. The county recorder shall cancel the registration on receipt of notice of a felony conviction from the court or from the secretary of state or when reported by the elector on a signed juror questionnaire that is completed pursuant to section 21-314.

5. On production of a certified copy of a judgment directing a cancellation to be made.

6. Promptly after the election if the person registered has applied for a ballot pursuant to section 16-126.

7. When a person has been on the inactive voter list and has not voted during the time periods prescribed in section 16-166, subsection C.

8. When the county recorder receives written information from the person registered that the person has a change of residence within the county and the person does not complete and return a new registration form within twenty-nine days after the county recorder mails notification of the need to complete and return a new registration form with current information.

9. When the county recorder receives written information from the person registered that the person has a change of address outside the county.

B. If the county recorder cancels a registration pursuant to subsection A, paragraph 8 of this section, the county recorder shall send the person notice that the registration has been cancelled and a registration form with the information described in section 16-131, subsection C attached to the form.

C. When proceedings in the superior court or the United States district court result in a person being declared incapable of taking care of himself and managing his property, and for whom a guardian of the person and estate is appointed, result in such person being committed as an insane person or result in a person being convicted of a felony, the clerk of the superior court in the county in which those proceedings occurred shall file with the secretary of state an official notice of that fact. The secretary of state shall notify the appropriate county recorder and the recorder shall cancel the name of the person on the register. Such notice shall name the person covered, shall give the person's date and place of birth if available, the person's social security number, if available, the person's usual place of residence, the person's address and the date of the notice, and shall be filed with the recorder of the county where the person last resided.


D. Each month the department of health services shall transmit to the secretary of state without charge a record of the death of every resident of the state reported to the department within the preceding month. This record shall include only the name of the decedent, the decedent's date of birth, the decedent's date of death, the decedent's social security number, if available, the decedent's usual legal residence at the time of death and, if available, the decedent's father's name or mother's maiden name. The secretary of state shall use the record for the sole purpose of canceling the names of deceased persons from the statewide voter registration database. In addition, the department of health services shall annually provide to the secretary of state from the statewide electronic death registration system without charge a record of all deaths of residents of this state that are reported to the department of health services. The records transmitted by the department of health services shall include only the name of the decedent, the decedent's date of birth, the decedent's social security number, if available, the decedent's usual legal residence at the time of death and, if available, the decedent's father's name or mother's maiden name. The secretary of state ~~may~~ **SHALL** compare the records of deaths with the statewide voter registration database. Public access to the records is prohibited. Use of information from the records for purposes other than those required by this section is prohibited. The name of each deceased person shall promptly be canceled from the statewide voter registration database and the secretary of state shall notify the appropriate county recorder and the recorder shall cancel the name of the person from the register.




The only change this bill is making is removing the word “may” and replacing it with “SHALL”. The impact is now the Secretary of State must compare death records to the voter database. Whereas prior to this bill, it was optional.







Email Tips

You can use the same messaging format from the previous slides for your emails.

Keep the subject 5 words or less, put it in ALL CAPS, & make it compelling!

How to See How Legislators Voted on a Bill

After looking up the bill on Azleg.gov Bill Status Inquiry screen, click on Bill Status

Click on Standing or Vote Details

How Does a Committee Session Work?

{What Do You Need to Know if You Sign Up to Speak?}

- The Chair of the Committee runs the meeting and determines how long each speaker is allowed to speak. Be prepared to only speak for 1 min.
- The meeting will last as long as the Chair wants it to run or for as long as quorum is maintained. Quorum is the minimum number of legislators needed in order for the meeting to be valid.
- Be professional in the meeting. No clapping or sound effects.
- All speakers speak through the Chair.
 - i.e. before anyone speaks, they say “Chairman” before addressing the person they are directing their next statement to.
- When making your public comment, state your name, identify your comment as speaking for yourself or representing an organization, and then reference the Chair and members before beginning your comment.
- Always keep your comments focused on the bill. Be persuasive keeping in mind the self-interests of the committee members. Sharing a short personal story pertinent to the bill can be very powerful.
- If you want the Chair or the members of the Committee to ask you additional questions, at the end of your comments say, “and with that I will take questions.”


